"Platte River is proud to support one of our owner communities through sponsoring the inaugural State of Estes Park event," shares Jason Frisbie, general manager



The State Purchasing and Contracts Office (SPCO) offers free training on a variety of topics for the procurement community.


On November 18, 2025, the State will host a free webinar on how to do business with the State of Colorado.
